Herewith I re-submit the paper for SMC.

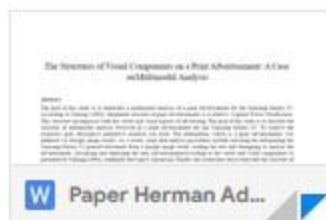
